**Propomint spray for children** is formulated on the basis of standardized propolis extract, Iceland moss and N-acetylcysteine and it is intended for preserving the health of throat, mouth and gum mucosa.

**Propolis** contained in this product is a natural substance which, owing to its numerous healing ingredients, has been used for over 2000 years. It is produced by bees for the purpose of closing their hives, thus protecting them from harmful effects of various microorganisms. Its pronounced antimicrobial and anti-inflammatory properties alleviate the symptoms of throat and tonsils inflammation, throat irritation and dry cough, gum diseases, aphthae, etc. It also has antiviral properties, which is why it is used to help with the symptoms of colds and the flu, by shortening the duration of illnesses and strengthening the immune system. It is also recommended for healthy persons, especially those prone to frequent infections. Propolis can be used as the first line of defense against bacterial infections, as a supplement to antibiotic therapy. Propomint spray for children contains propolis standardized to polyphenols, thus achieving the optimal effect of this active principle.

**Iceland moss** has traditionally been used as respiratory disease therapy. Polysaccharides contained in this plant coat the inflamed and irritated mucosa of the mouth and pharynx, thus alleviating a dry and irritable cough. Usnic acid, the integral part of Iceland moss, has antibiotic properties, which is why it is considered a valuable natural antibiotic which can be helpful for treating colds and the flu, accompanied by cough and hoarseness. Its use is recommended as prevention as well, so as to protect the dry mucosa of upper airways, often occurring during winter. Propomint spray for children contains Iceland moss extract, standardized to 30% of polysaccharides.

**N-acetylcysteine** is a derivative of proteinogenic amino-acid L-cysteine and a powerful mucolytic. It is used in acute and chronic airway inflammatory diseases accompanied by overproduction of phlegm and difficult removal of secretion by coughing. It acts by decreasing the viscosity of the accumulated phlegm and facilitates its excretion from the respiratory organs. N-acetylcysteine is recommended as a supplement in the therapy of virus infections, sinusitis, bronchitis and other respiratory conditions. N-acetylcysteine, along with propolis and Iceland moss contained in Propomint spray for children, helps with all types of oral cavity and pharynx infections, whether bacterial, viral or fungal. It is recommended for alleviating irritations of the throat and dry cough, as well as for inflamed gums and aphthae therapy. Formulated without alcohol, with the addition of honey and spearmint aroma which contribute to its pleasant taste, Propomint spray for children is suitable for youngest.

## Usage:

Children older than 3 years: 4 times a day 1 spray dose.

Remove the protective cap from the nozzle prior to use. Raise the nozzle and direct it towards the mouth, then press.

**Notes:** Dietary supplements are not a substitute for a balanced nutrition.

The recommended daily intake must not be exceeded. Shake before use. Precipitate may form in the product.

Keep out of reach of children.

**Special warnings:** This product is not intended for persons oversensitive to propolis or other ingredients. Not recommended for pregnant and nursing women and children under 3 years of age, without prior consultation with a doctor or pharmacist. During usage of N-acetylcysteine based products, higher intake of liquids is recommended.

**Storage:** Keep the product in its original packaging, in a dry and dark place, at a temperature of up to 25°C.

**Shelf life:** 3 years.

Packaging: 30 ml dark glass bottle with a spray cap.
